**ORDER GRANTING RECEIVER'S MOTION TO (A) AUTHORIZE THE
EMPLOYMENT OF STRETTO, INC. AS NOTICING AND CLAIMS AGENT; AND (B)
APPROVE PROPOSED NOTICING AND CLAIMS PROCESS**

This matter came before the Court on October 21, 2024, on the Receiver Seth Heller's (the "Receiver") Motion to (a) Authorize the Employment of Stretto, Inc. ("Stretto") as Noticing and Claims Agent; and (b) Approve the Proposed Noticing and Claims Process (Doc. 107) (the "Motion"). No objections to the Motion were filed or raised at the hearing. The Court, having considered the Motion and being fully advised, **ORDERS** as follows:

1. The Motion is granted.
2. The Receiver is authorized to employ Stretto as his noticing and claims agent on the terms and conditions set forth in the Motion and the Services Agreement attached as Exhibit A thereto. The Receiver is authorized to enter into the Services Agreement and to compensate Stretto from receivership assets in accordance therewith without further Order of the Court.
3. Each person or entity that asserts any claim against Priority Capital Solutions, Inc., KIT Holdings, Inc. Broad Capital Solutions, LLC, USD Funding, LLC (the "Receivership Entities") must submit a completed Proof of Claim in substantially the form attached to the Motion as Exhibit C by either (a) the Receiver's electronic claims portal at

<https://cases.stretto.com/PriorityCapitalSolution>; (b) U.S. Mail to Priority Solutions Capital, Inc. et al. Receiverships Claims Processing,, c/o Stretto, 410 Exchange, Suite 100, Irvine, CA 92602; (c) email to PriorityCapitalSolutionsClaims@Stretto.com, to be received on or before 60 days from the service by U.S. Mail of the Proof of Claim Form to known possible claimants (the “Claim Bar Date”). Any person or entity that fails to submit a claim to the Receiver on or before the Claim Bar Date (i.e., fails to take the necessary steps to ensure that the Proof of Claim Form is received by the Receiver on or before the Claim Bar Date), shall be forever barred and precluded from asserting any claim against any Receivership Entities or the receivership estates.

4. The notice procedures for the Claim Bar Date provided in the Motion shall be sufficient and reasonably calculated to provide notice to all creditors if made by (a) first class U.S. mail to the last known addresses of known potential claimants, (b) by email to the email address of known potential claimants; and (c) by publication in newspapers of general circulation in Miami-Dade County, Florida and Palm Beach County, Florida once a week for two consecutive weeks. The Court hereby authorizes that the costs of publication be paid directly from receivership assets. 5. The notice described in the preceding Paragraph shall be in substantially the form attached to the Motion as Exhibit B.
