1 disburse funds to the holders of certain allowed unsecured claims in the amounts outlined in
2 **Exhibit A** to the Motion, which is attached hereto.

3 3. The Trustee is authorized to withhold from the distribution to any wage claims the
4 employee's share of withholding taxes and is authorized to pay the employer's share of such
5 withholding taxes.

6 4. The Trustee is authorized to make pro rata disbursements to disputed creditors upon
7 resolution of their claims by compromise of such claims without further order of the court so long as
8 their allowed claim does not exceed the amount of the disputed claims and reserved disbursement
9 amounts reflected in **Exhibit A**.

10 5. To safely pay such claims the Trustee is authorized to distribute interim claim
11 payments in excess of \$500,000 via wire transfer.
