**ORDER AND NOTICE FOR HEARING ON DISCLOSURE STATEMENT ON
DEBTORS' JOINT PLAN OF REORGANIZATION AND ESTABLISHING DEADLINE
FOR OBJECTIONS**

To the Debtors, their creditors, equity security holders, and other parties in interest:

On August 10, 2020, the Debtors filed their Plan of Reorganization (the "Plan") under Chapter 11 of the Bankruptcy Code and a Disclosure Statement to accompany the Plan (the "Disclosure Statement") and the Court being otherwise sufficiently advised and having considered the same,

IT IS HEREBY ORDERED and NOTICE is hereby given as follows:

1. A hearing to consider the approval of the Disclosure Statement, as may be amended, shall be held at the United States Bankruptcy Court in Courtroom Three, Customs House, 701 Broadway, Nashville, Tennessee 37203, on September 10, 2020, at 1:30 p.m. The hearing for approval of the Disclosure Statement may be adjourned from time to time by announcement made in open Court without further written notice to creditors and parties in interest. 2. September 8, 2020 is fixed as the last date of filing and serving in accordance with Fed. R. Bankr. P. 3017(a) written objections to the adequacy of the information in the Disclosure Statement.

3. The Debtors shall serve the Disclosure Statement, the Plan and this Order in accordance with Fed. R. Bankr. P. 3017(a) and Local Rule 3016-2 as soon as practicable after entry of this Order.
