**SECOND AGREED ORDER EXTENDING TEMPORARY RESTRAINING ORDER

In accordance with this Court's *Order Regarding Defendants' Emergency Motion for Conversion of the June 27, 2023 Evidentiary Hearing Into Status Conference* [Dkt. No. 14], and pursuant to Fed. R. Civ. P. 65(b)(2), the parties in the above-captioned adversary proceeding agree

to further extend the *Temporary Restraining Order* [Dkt. No. 7] through and including July 10, 2023, and to continue the evidentiary hearing presently set for July 5, 2023 at 3:00 p.m. to July 10, 2023, it is **ORDERED THAT:**

1. The *Temporary Restraining Order* [Dkt. No. 7] is hereby extended through July 10, 2023 based on the commitments provided by Defendants to provide the Official Committee of Equity Securities Holders with certain discovery, including interviews with representatives of the Defendants, to be completed on or before July 5, 2023.

2. The Court will conduct the hearing to consider the request for a preliminary injunction on July 10, 2023, at 1:30 p.m. (prevailing Central Time) in Courtroom 400, 515 Rusk Street, Houston, Texas.

3. Nothing in this Order shall prejudice or be deemed to prejudice, impair, or otherwise alter or affect the rights, arguments, or defenses of the parties, including the right to seek amendment of this Order should the parties reach any further agreement(s) with respect to the Temporary Restraining Order or this Order.
