

To the Agent for Service of Process for Western Global Airlines, Inc.:

Our law firm has been retained by Virgilio Sangual, regarding his past employment and relationship with Western Global Airlines, Inc. (Respondent). After conducting our initial investigation, we have determined it to be clearly evident that our client's employment rights were violated. As a consequence of these blatant violations, Respondent owes Mr. Sangual significant damages and compensatory amounts to be determined by applicable California employment law.

Based on our firm's preliminary investigation of Mr. Sangual's claims, our legal recommendation is that he commence and prosecute claims against Respondent including, but not limited to the following: Violation of Labor Code § 1102.5, Wrongful Termination in Violation of Public Policy, Discrimination, Retaliation in Violation of the FEHA & Failure to Prevent Discrimination and Retaliation, Failure to Pay Wages in a Timely Manner, Failure to Pay All Wages Due Upon Termination, and Waiting Time Penalties.
