1 The court having read and considered the *Notice of Motion and Motion for Order Setting*
2 *Bar Date For Filing Proofs of Claim* (the “Motion”), [Docket 191] filed by Ittella International
3 LLC (“Ittella”), Ittella’s Chef, LLC (“ICLLC”), Tattooed Chef, Inc. (“TCI”), Myjojo, Inc.
4 (“Myjojo”), New Mexico Food Distributors, Inc. (“NMFD”), Karsten Tortilla Factory, LLC
5 (“Karsten”), BCI Acquisition, Inc. (“BCI”), and TTCF-NM Holdings Inc. (“TTCF”, and,
6 together with Ittella, ICLLC, TCI, Myjojo, NMFD, Karsten, and BCI, the “Debtors”), the
7 debtors and debtors in possession in the above-captioned jointly administered Chapter 11
8 bankruptcy cases, and good cause appearing,

9 **IT IS HEREBY ORDERED THAT:**
