**ADMINISTRATIVE EXPENSE PRIORITY
CLAIMS BAR DATE: JANUARY 19, 2024**

1 **PLEASE TAKE NOTICE** that, pursuant to an order entered by the Bankruptcy Court, the
2 deadline (“Admin. Claim Bar Date”) by which parties, other than the United States Trustee, the Clerk of
3 the Court, and professionals employed at the expense of the estates herein, must file and serve requests
4 for the allowance and payment of administrative expense priority claims (“Admin. Claims”) of the kind
5 described in 11 U.S.C. § 503(b), that are entitled to priority under 11 U.S.C. § 507(a)(2), and that were
6 incurred or accrued or arose on or before the cutoff date (the “Cutoff Date”) of December 31, 2023 (the
7 “Admin. Claim Requests” and each an “Admin. Claim Request”) is **January 19, 2024**.

8 **PLEASE TAKE FURTHER NOTICE** that, with respect to filing Admin. Claim Requests:

9 1. 11 U.S.C. §§ 503(b) and 507(a)(2) of Title 11 of the United States Code provide for
10 the allowance of Admin. Claims in a bankruptcy case. Should you be uncertain as to whether it is
11 necessary for you to file an Admin. Claim Request, please consult your own attorney.

12 2. Any person or entity who wishes to assert Admin. Claims in this case must file an
13 Admin. Claim Request with the Bankruptcy Court on or before the Admin. Claim Bar Date set
14 forth above, and serve a copy on counsel for the Debtors, whose contact information appears in
15 the upper left-hand corner of the first page of this Notice.

16 3. Any Admin. Claim Request previously filed with the Bankruptcy Court before the
17 mailing of this Notice shall be deemed to be, and shall be treated as, a properly filed Admin. Claim
18 Request, subject to the right of the Debtors, the Official Committee of Unsecured Creditors
19 appointed in the Ittella International LLC and New Mexico Food Distributors, Inc. bankruptcy
20 cases (each a “Committee” and together, the “Committees”) and/or any party in interest to object
21 to the allowance thereof.

22 4. Claimants asserting Admin. Claims shall not set hearings on their Admin. Claim
23 Requests.

24 5. A hearing on any Admin. Claim Request shall only be set in the event there is a
25 dispute regarding the Admin. Claim Request and the Debtors and/or the Committees and the
26 subject claimant are not able to resolve the dispute, in which case the Debtors and/or the
27 Committees shall set the Admin. Claim Request for hearing on not less than fourteen (14) days’

1 notice and provide notice thereof to the subject claimant and other parties entitled to notice of the
2 hearing on the Admin. Claim Request.

3 **PLEASE TAKE FURTHER NOTICE that any person or entity (other than professionals**
4 **employed at the expense of the estates herein) that fails to file and serve an Admin. Claim Request**
5 **by the Admin. Claim Bar Date shall be barred from thereafter asserting a right to payment of any**
6 **Admin Claim that that was incurred or accrued or arose on or before the Cutoff Date of December**
7 **31, 2023.**
