Dundon Advisers LLC (“**Dundon**” or the “**Applicant**”), as financial advisor to Ellen E. Ostrow (the “**Trustee**”), the duly-appointed trustee in the above-entitled Chapter 7 Bankruptcy Case (the “**Bankruptcy Case**”) filed by SafeMoon US LLC (the “**Debtor**”), pursuant to sections §§ 330 and 331 of title 11 of the United States Code (the “**Bankruptcy Code**”) and Rule 2016 of the Federal Rules of Bankruptcy Procedure (the “**Bankruptcy Rules**”), files this first interim application for compensation for professional services rendered, and for reimbursement for actual and necessary costs and expenses incurred (the “**Interim Fee Application**”) for the period of December 20, 2023 through October 31, 2024 (the “**Fee Period**”). In support of the Interim Fee Application, Dundon respectfully represents as follows:

JURISDICTION AND VENUE

1. The Court has jurisdiction over this Interim Fee Application pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b)(2). Venue of the Bankruptcy Case and this proceeding is proper in this district pursuant to 28 U.S.C. §§ 1408 and 1409.

2. The bases for the relief requested herein are §§ 330 and 331 of the Bankruptcy Code and Rule 2016 of the Bankruptcy Rules.

BACKGROUND

A. Bankruptcy Case

3. The Debtor was a cryptocurrency and blockchain company based in Pleasant Grove, Utah. The Debtor was created in March 2021. Concurrently with its inception, the Debtor created and sold a SafeMoon token (“**SFM Token**”) that trades on the BNB Chain (Binance)

blockchain. The value of the SFM Token increased exponentially in its first month of existence, resulting in the total market value of the token rising to the billions of dollars in April 2021.

4. Over time, however, allegations that the Debtor's principals made misrepresentations and engaged in other alleged misconduct led to a sharp reduction in the market price of the SFM Tokens.

5. On February 17, 2022, certain individuals filed a class action complaint against the Debtor, Braden John Karony (the Debtor's former CEO), Kyle Nagy (the Debtor's founder), and various other executives and/or insiders of the Debtor, in the United States District Court for the District of Utah (the "***Class Action Complaint***"). *See Combs et al v. SafeMoon LLC et al*, Case No. 22-cv-00642 (D. Utah). In the Class Action Complaint, as it has been amended, the plaintiffs allege that the Debtor and other defendants violated, among other things, Section 10(b) of the Securities Exchange Act of 1934 (15 U.S.C. §78j(b)) (the "***Exchange Act***"), Rule 10b-5(b) promulgated thereof, and various other federal and state laws by making false statements of material fact and engaging in a scheme to defraud investors relating to the purchase or sale of a security (i.e., the SFM Token).

6. On November 1, 2023, the Securities and Exchange Commission ("***SEC***") filed a Complaint against the Debtor and others in the United States District Court for the Eastern District of New York. *See Securities and Exchange Commission v. SafeMoon LLC et al*, Case No. 23-08138 (E.D.N.Y.) (the "***SEC Case***"). In the SEC Case, the SEC asserts various claims against the Debtor and other Defendants under the Exchange Act, Rule 10b-5 and the Securities Act of 1933 (15 U.S.C. § 77a *et seq.*).

7. The Debtor commenced the Bankruptcy Case on December 14, 2023 (the “**Petition Date**”) by filing a voluntary petition for relief under Chapter 7 of the Bankruptcy Code.

8. The Trustee is the duly qualified and acting Chapter 7 trustee in the Bankruptcy Case.

B. Retention of Dundon Advisers LLC

9. On December 29, 2023, the Trustee filed the *Application of Ellen E. Ostrow, Chapter 7 Trustee, for Entry of an Order Authorizing the Trustee to Retain and Employ Dundon Advisers LLC as her Financial Advisor Effective as of December 20, 2023* [Dkt. No. 18] (the “**Dundon Retention Application**”).

10. As set forth in the Dundon Retention Application, the Trustee determined that the services of a financial advisor were necessary to enable her to administer the Estate in the Bankruptcy Case. The Trustee retained Dundon to render services to her in the Bankruptcy Case, including, without limitation, the following:

- a. *Analyzing the business, assets, liabilities, and financial affairs of the Debtor and the Estate;*
- b. *Analyzing the Debtor’s Statements and Schedules, and valuing the Debtor’s assets, liabilities and financial affairs as requested by the Trustee;*
- c. *Assisting in the analysis, review, and monitoring of the bankruptcy process, including but not limited to, an assessment of the unsecured claims pool and potential recoveries for unsecured creditors;*
- d. *Assisting the Trustee in securing, protecting and liquidating cryptocurrency assets of the Debtor;*
- e. *Assisting the Trustee in marketing and monetizing the Debtor’s assets and evaluating whether a sale or sales of those assets is appropriate and in the best interests of the Estate;*

- f. Assisting the Trustee in investigating potential claims and causes of action against various parties;*
- g. Advising the Trustee about the Estate's assets, and helping the Trustee monetize unencumbered assets for the benefit of creditors;*
- h. Assisting the Trustee in analyzing and pursuing any proposed dispositions of assets of the Estate;*
- i. Pursuing any claims and causes of action of the Estate, including, but not limited to Chapter 5 avoidance claims and any state-law claims;*
- j. Defending the Trustee and the Estate in any litigation matters which may be asserted, including the defense of motions seeking relief from the automatic stay;*
- k. Assisting the Trustee in providing information to creditors and other parties in interest;*

Reviewing, analyzing, and advising the Trustee regarding fee applications or other issues involving professional compensation in the Bankruptcy Case;
- l. Assisting the Trustee in negotiations with various creditor constituencies regarding treatment, resolution, and payment of creditor claims; and*
- m. Performing all other necessary financial services as may be required by the needs of the Trustee in the Bankruptcy Case.*
- n. Determining whether there are viable alternative paths for the disposition of the Debtors' assets from those being currently proposed by the Debtors, such as alternative buyers or partial sales of the Debtor's assets to different purchasers;*
- o. Assisting the Trustee in identifying, valuing, and pursuing estate causes of action, including but not limited to, relating to pre-petition transactions, control person liability, and lender liability;*
- p. Assisting the Trustee in preparing Debtor's financial reports, including, but not limited to, statements of financial affairs, schedules of assets and liabilities, cash budgets, and monthly operating reports;*
- q. Attending meetings and assist in discussions with the Trustee, the Debtor, the U.S. Trustee, other parties in interest and professionals;*
- r. Performing such other advisory services for the Trustee as may be necessary or proper in these proceedings, subject to the aforementioned scope; and*
- s. Provide testimony on behalf of the Trustee as and when may be deemed*

appropriate.

11. On January 24, 2024, the Court entered an order granting the Dundon Retention Application [Dkt. No. 48] (the “**Dundon Retention Order**”).

C. Dundon’s Assistance to the Trustee During the Fee Period

12. While the Debtor was no longer marketing SafeMoon tokens (“**SFM Tokens**”) as of the Petition Date, an immediate liquidation of all assets by the Trustee would have been detrimental to the estate and its creditors. The Trustee needed to maintain the Debtor’s platform to, among other things, transition certain crypto wallets, market and sell the Debtor’s operating assets, liquidate substantial crypto assets and convert them to cash, and manage crypto “liquidity pools.” Accordingly, pursuant to § 721, Dundon worked with counsel to the Trustee, Foley & Lardner LLP (“**Foley**”) in assisting the Trustee in obtaining the authority to hire certain former employees of the Debtor as independent contractors and operate the Debtor’s business for a limited time (the “**721 Order**”). *See* Docket No. 15. The Bankruptcy Court renewed the Trustee’s authority to operate the Debtor’s business pursuant to the 721 Order on multiple occasions, until it expired on April 25, 2024. *See* Docket Nos. 35, 73 and 146.

13. The Trustee, with the assistance of Foley and Dundon, has made significant progress converting the Debtor’s assets to cash in this chapter 7 case. *First*, the Trustee, with the assistance of Foley and Dundon, converted substantial Ethereum to cash pursuant to the authority granted to the Trustee under the 721 Order. *Second*, pursuant to authority provided by the Bankruptcy Court and after an extensive bidding process, the Trustee, with Foley and Dundon’s assistance, sold a substantial portion of the Debtor’s remaining cryptocurrency assets to an offshore trading partner for a total of \$15,393,900. *See* Docket No. 135 (*Order Granting Motion*

to Sell Property Free and Clear of Liens Under Section 363(f)), and Docket No. 170 (*Notice of Cryptocurrency Sale*).

14. *Third*, after a marketing process run by Dundon and pursuant to procedures approved by the Bankruptcy Court, Dundon assisted the Trustee in selling the Debtor's operating assets to two buyers for a total of \$350,000. *See* Docket No. 169. *Finally*, the Trustee obtained authority to sell certain token assets of the Debtor for a total of \$150,000 (the "***Token Sale***"). *See* Docket No. 226.

15. As of the date hereof, the Trustee is holding a total of \$17,766,859.78 in cash. The Trustee also possesses certain cryptocurrency assets of the Debtor that are not yet available for sale. The Trustee also possesses causes of action that could be brought on behalf of the Debtor's estate.

16. Further, pursuant to an Order of the Bankruptcy Court, Docket No. 152 (the "***Bar Date Order***"), and after substantial work by Foley and Dundon, the Trustee established a deadline of July 22, 2024 for any creditor to file a proof of claim against the Debtor's estate. Because the identity of SFM Token holders is not generally known, the Trustee published the bar date on the Debtor's social media platforms and advertised it in a crypto-industry publication to maximize the exposure of that deadline.

17. Approximately 1,171 claimants filed claims for a total of approximately \$91 million. The Trustee and her advisors are reviewing the claims. The Trustee also engaged in a mediation with the Class Plaintiffs. Subject to certain conditions, which have yet to be resolved, the Trustee believes she will be able to file 9019 motion before the court approving the proposed settlement.

**SUMMARY OF PROFESSIONAL COMPENSATION
AND REIMBURSEMENT OF EXPENSES**

18. By this Interim Fee Application, Dundon requests interim approval of compensation for services rendered during the Fee Period in the amount of \$546,926.00, as well as allowance of \$313.80 as reimbursement for actual and necessary expenses incurred by Dundon during the Fee Period.

19. Dundon maintains computerized records of the time spent by all timekeepers in connection with its representation of the Trustee. Nine (9) professionals expended a total of 710.80 hours during the Fee Period for which compensation is requested. All services for which compensation is requested by Dundon were performed for or on behalf of the Trustee.

20. Dundon has received no payment and no promises of payment from any source for services rendered or to be rendered in any capacity whatsoever in connection with the matters covered by this Interim Fee Application. There is no agreement or understanding between Dundon and any other person, other than members of the firm, for the sharing of compensation to be received for services rendered in the Bankruptcy Case.

21. The fees charged by Dundon in the Bankruptcy Case are billed in accordance with the Dundon Retention Application and Dundon's hourly rates and procedures in effect during the Fee Period and as discounted as set forth in the Dundon Retention Application. Dundon's fees are reasonable based on the customary compensation charged by comparably skilled practitioners in comparable non-bankruptcy cases in a competitive national legal market. Pursuant to Paragraph 21 of the Dundon Retention Application, Dundon agreed to discount its standard rate fees by 25%. Further, pursuant to Paragraph 22 of the Dundon Retention Application, Dundon is entitled to recover the full amount of such discounted amount based on a sliding scale of a percentage of

recoveries by the Trustee (2.5% of the first \$5,000,000, 3.0% of the next \$3,000,000 and 3.5% thereafter). As outlined above, the huge successes of the Trustee in recovering assets exceeds \$15,000,000. Based on the agreed schedule, Dundon is entitled to recover the full amount of the deferred portion of such fees and thus by this Application seeks full reimbursement of its fees at this time.

22. In support of this Interim Fee Application, attached hereto as **Exhibit A** is a summary of compensation by each professional of the Applicant that worked on the Bankruptcy Case during the Fee Period; (ii) attached hereto as **Exhibit B** is a summary of compensation by project category during the Fee Period; (iii) attached hereto as **Exhibit C** is the expense summary for the Fee Period; and (iv) attached hereto as **Exhibit D** is a copy of the Applicant's time detail for the Fee Period.

SUMMARY OF SERVICES PROJECT CATEGORY

23. The following is a summary of the significant professional services rendered by Dundon during the Fee Period. This summary is organized in accordance with the internal system of task codes set up by Dundon at the outset of the Bankruptcy Case. Given the interconnectedness of the issues in the Bankruptcy Case, certain of these categories may overlap with one another. If a task code does not appear below, then Dundon did not bill time for that work code during the Fee Period but may bill time for that work code in the future.

(A) Business Analysis
Hours: 297.40
Fees: \$219,069.00

24. This category includes time spent by Dundon professionals analyzing issues related to the Debtor's business and operations generally. Dundon professionals spent time transitioning with M3 the Chapter 11 advisors. Dundon spent time understanding and unlocking the liquidity pools and working with prior management to identify and secure the Debtor's assets. Dundon professionals spent time identifying the various wallets holding crypto assets and created a secure wallet under the control of the Trustee. Dundon professionals worked with former employees to identify assets and to secure them and then transfer them to the Trustee controlled wallet. Dundon professionals prepared the monthly operating reports. Dundon professionals also incurred time addressing operational issues such as the maintenance of the Debtor's cryptocurrency wallets, notifying walletholders of the need to transfer their funds in the event of decommission of the wallets, addressing patent matters, and addressing license and contract issues with AWS and other various vendors

(B) Case Administration
Hours: 12.70
Fees: \$9,118.00

25. This category includes fees applicable to a broad scope of services intended to assist the Trustee and her professionals in fulfilling their responsibilities, including, but not limited to: (i) time spent analyzing the Debtor and its operations including with the Debtor's former employees and advisors; (ii) preparation and maintenance of the payroll for contractors; and (iii) other tasks associated with the day-to-day representation of the Trustee not characterized under

any specific task, or during the initial stages of the Bankruptcy Case in anticipation of likely issues arising in other categories.

(C) Claims Analysis
Hours: 15.10
Fees: \$13,549.00

26. This category comprises of identification and review of potential assets that belong to the Estate, including claims and causes of action against insiders and the Debtor's past conduct. Dundon personnel spent time analyzing and valuing such claims in support of the Trustees.

(D) Sale Process
Hours: 228.20
Fees: \$180,071.00

27. Dundon spent considerable time in the Fee Period on asset disposition. The various sales of assets of the Debtor's estate generated a total of approximately \$15,500,000 and were a critical step toward making significant distributions to creditors in the future.

28. This category includes time incurred by Dundon professionals to (i) run a fulsome marketing process for the Debtors operating assets, including preparing all marketing documentation, teasers, product descriptions, market outreach to numerous parties and coordination of the auction process. These efforts resulted in a successful 363 sale of those assets. Dundon also worked with numerous potential buyers of the cryptocurrency assets , and reviewed various proposals for the sale of the Debtor's cryptocurrency assets, and negotiate such proposals with potential buyers; (ii); (iii) analysis of issues raised by the SEC in connection with such sales; (iv) analyze and revise drafts of cryptocurrency purchase agreements with prospective buyers; (v).

(E) Meetings of and Communications with Professionals

Hours: 153.80

Fees: \$122,209.00

29. This category includes time incurred by Dundon engaging in conversations and coordinating with the Trustee and her other professionals, updates and workflow coordination and responding to specific case issues identified by the Trustee .

(F) Retention and Fee Applications

Hours: 3.60

Fees: \$2,910.00

30. This category includes work conducted in relation to the preparation of the application to employ Dundon as financial advisor to the Trustee, the engagement of Stretto as claims agent to the Trustee, and the preparation of this Interim Fee Application.

31. The foregoing professional services performed by Dundon were necessary and appropriate to the administration of the Bankruptcy Case. Compensation for the foregoing services as requested is commensurate with the complexity, importance, and nature of the problems, issues, or tasks involved. The professional services were performed with expedition and in an efficient manner.

ACTUAL AND NECESSARY DISBURSEMENTS

32. Dundon requests allowance of actual and necessary expenses incurred during the Fee Period in the aggregate amount of \$313.80. The attached **Exhibit C** includes copies of Dundon's itemized actual and necessary expenses.

33. Dundon's disbursement policies pass through all out-of-pocket expenses at actual cost or an estimated actual cost when the actual cost is difficult to determine.

JUSTIFICATION FOR AWARD

34. All services for which compensation is requested by Dundon were performed for or on behalf of the Trustee.

35. Section 330(a) of the Bankruptcy Code governs compensation of professionals in bankruptcy matters. *See In re Market Center East Retail Property, Inc.*, 730 F.3d 1239, 1246 (10th Cir. 2013). Section 330(a) provides, in relevant part, as follows:

the court shall consider the nature, the extent, and the value of such services, taking into account all relevant factors, including –

(A) the time spent on such services;

(B) the rates charged for such services;

(C) whether the services were necessary to the administration of, or beneficial at the time at which the service was rendered toward the completion of, a case under this title;

(D) whether the services were performed within a reasonable amount of time commensurate with the complexity, importance, and nature of the problem, issue, or task addressed; and

(E) whether the compensation is reasonable based on the customary compensation charged by comparably skilled practitioners in cases other than cases under this title.

11 U.S.C. § 330(a)(3). Under section 331 of the Bankruptcy Code, compensation for professional services may be awarded on an interim basis. 11 U.S.C. § 331.

36. The Tenth Circuit has applied the factors originally set forth in *Johnson v. Georgia Highway Express, Inc.*, 488 F.2d 714 (5th Cir. 1974) in determining “reasonableness” of attorneys’ fees. *See In re Market Center East Retail Property, Inc.*, 730 F.3d 1239, 1246 (10th Cir. 2013). The *Johnson* factors to be considered are delineated below, and Dundon’s compliance therewith, if applicable, is described following each factor:

- a. **Time and Labor Required. Exhibit B** to this Interim Fee Application delineates all of the work performed by Dundon for which compensation is requested during the Fee Period. Dundon submits that the information contained in this exhibit supports the fees requested and reflects the reasonableness of such fees.
- b. **Novelty and Difficulty.** Dundon believes that various issues involved in these cases have been complex and challenging. This Bankruptcy Case has required professionals to expend relatively significant time getting up the learning curve with respect to the Debtor and its operations, particularly in light of the cryptocurrency issues,. The specific circumstances of the Bankruptcy Case, including the class action lawsuit and the criminal and civil lawsuits pending against the Debtor's founder and CEO, have also contributed to the complex nature of this engagement.
- c. **Skill Requisite to Perform the Services Properly.** The professionals primarily working on this matter are specialists in matters such as asset sales, managing a liquidation, the claims process and pursuit of causes of action that have provided significant value to the Trustee.
- d. **Preclusion of Other Employment.** The time demands of representation of the Trustee in the Bankruptcy Case resulted in some disruption of other employment engagements undertaken by Dundon. While no large-scale reassignment of work has been required to properly represent the Trustee, this representation did consume a significant amount of time and preclude work for other clients.
- e. **Customary Fee.** The hourly rates charged for each professional and paraprofessional performing services are no greater, and in some instances may be lower, than those being charged by professionals with similar qualifications and experience. The hourly rates requested herein compare favorably with average costs for similar advisory services being provided nationally and regionally.
- f. **Whether the Fee is Fixed or Contingent.** Dundon's fees are neither fixed nor contingent other than on the contingency of allowance by the Court and availability of assets for payment. Fees are based on the actual total number of hours worked, less hours written off, plus actual expenses incurred.
- g. **Time Limitations.** The representation of a Trustee in a chapter 7 case is inherently time sensitive, particularly in the first few months of a proceeding such as this one in which time is of the essence. Dundon was required to provide capable representation within the time limitations imposed by the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, counsel for various parties in interest, and this Court.

- h. **Amount Involved and Results Obtained.** Dundon has assisted the Trustee in all facets of the Bankruptcy Case. Dundon believes that the information contained herein and in the attached exhibits, as well as the record in these proceedings, support the reasonableness of its requested compensation.
- i. **Experience, Reputation, and Ability of the Professionals.** Dundon's advisors have regularly appeared in significant representations over many years, including bankruptcy cases in this District and throughout the United States.
- j. **Undesirability of Case.** Dundon has not found the Bankruptcy Case to be undesirable, but rather, considers the issues that have been raised in the Bankruptcy Case to be of the type that Dundon is trained to adequately address.
- k. **Nature and Length of Professional Relationship with Client.** Not applicable.
- l. **Awards in Similar Cases.** Based on Dundon's experience, the fees requested herein are commensurate with fees allowed in proceedings of similar scope for the services rendered.

37. Dundon has rendered substantial and valuable professional services on behalf of the Trustee that have resulted in a significant benefit to the creditors of the Debtor's Estate and to the administration of this complex Bankruptcy Case. Dundon's work in the Bankruptcy Case includes, without limitation, analysis of the Debtor's assets, including various forms of cryptocurrency, the development of a plan to recover and liquidate such assets, the negotiations for the sale of the Debtor's assets, through which the Trustee has realized approximately \$15,500,000 for the benefit of the Estate. In addition, Dundon has managed the claim noticing and administration process which was complicated by the lack of information the Debtor had on its customers. Dundon has also performed general bankruptcy tasks, including settlement with creditors, maintaining the Debtor's patent portfolio and addressed employee issues.

38. Dundon's services were provided with the requisite level of skill and were performed within a reasonable amount of time commensurate with the complexity, importance,

and nature of the problems, issues and tasks addressed. The amount sought in compensation is in line with awards in similar cases and is commensurate with the professional standing, ability, and expertise of Dundon and the professionals who have participated in this case but has been discounted as discussed below. Accordingly, the compensation requested herein reflects the reasonable value of the services Dundon provided to the Trustee.

39. Given the size of this case, the speed at which it has moved forward, and the significant amount of claims at issue (over \$91,000,000 in claims have been filed through the claims bar date), Dundon has been mindful of the need to avoid excessive fees in these cases and has taken all reasonable steps to provide cost-effective representation while rendering services with the highest degree of skill and professionalism. Such efforts include staffing this matter leanly and eliminating duplication of effort.

RESERVATION

40. To the extent time or disbursement charges for services rendered or disbursements incurred relate to the Fee Period but were not processed prior to the preparation of this Interim Fee Application, or Dundon has for any other reason not sought compensation or reimbursement of expenses herein with respect to any services rendered or expenses incurred during the Fee Period, Dundon reserves the right to request additional compensation for such services and reimbursement of such expenses in a future application.

WHEREFORE, Dundon respectfully requests (i) interim allowance of compensation for professional services rendered to the Trustee during the Fee Period in the amount of **\$546,926.00**, and for expenses incurred during the Fee Period in the amount of **\$313.80**, (ii) that the Court authorize the Trustee to pay Dundon a total of **\$547,239.80** representing the balance owed thereto,

(iii) that the interim allowance of such compensation for professional services rendered and reimbursement of actual and necessary expenses incurred be without prejudice to Dundon's right to seek such further compensation for the full value of services performed and expenses incurred, and (iv) that the Court grant Dundon such other and further relief as is just.
