Genesis Credit Partners LLC (the “Applicant” or “GCP”), co-Financial Advisor to the Official Committee of Unsecured Creditors (the “Committee”) of LL Flooring Holdings, Inc., *et al.*, and its affiliated debtors and debtors-in-possession (collectively, the “Debtors”) in the above-captioned chapter 11 cases (the “Chapter 11 Cases”), hereby submits this application (the “Application”) pursuant to (i) sections 330 and 331 of title 11 of the United States Code, 11 U.S.C. §§ 101–1532 (the “Bankruptcy Code”), (ii) Rule 2016 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), (iii) Rule 2016-2 of the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court for the District of Delaware (the “Local Rules”), and (iv) the *Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Retained Professionals* [Docket No. 209] (the “Interim

Compensation Order”),² for allowance of compensation for services rendered and reimbursement of expenses for (i) the monthly period from December 1, 2024 through December 20, 2024 (the “Monthly Period”) and (ii) the final period from August 23, 2024 through December 20, 2024 (the “Final Period”). In support of this Application, GCP respectfully represents as follows:

Jurisdiction and Venue

1. The Court has jurisdiction to consider the Application pursuant to 28 U.S.C. § 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b). Venue is proper in this District pursuant to 28 U.S.C. §§ 1408 and 1409.

2. Pursuant to Local Rule 9013-1(f), the Committee consents to entry of a final judgment or order with respect to this Application if it is determined that the Court does not have Article III jurisdiction to enter such final order or judgment absent consent of the parties.

3. The statutory predicates for the relief sought herein are sections 330 and 331 of the Bankruptcy Code. Such relief also is warranted under Bankruptcy Rule 2016, Local Rule 2016-2 and the Interim Compensation Order.

Background

A. The Chapter 11 Cases

4. On August 11, 2024 (the “Petition Date”), each of the Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code. These Chapter 11 Cases are being jointly administered for procedural purposes only pursuant to Bankruptcy Rule 1015(b).

5. On August 21, 2024, the Office of the United States Trustee for Region 3 (the “U.S. Trustee”) appointed a seven-member Committee consisting of: (i) Singapore Lioncore Industries Pte Ltd.; (ii) Ansen Technology Co., Ltd.; (iii) Welspun Global Brands Limited;

(iv) Beasley Flooring Products, Inc.; (v) United Surface Solutions LLC; (vi) Novalis US, LLC; and (vii) Macon Hardwood LLC. *See* Docket No. 116.

B. The Retention of GCP

6. On September 23, 2024, the Committee applied to the Court for an order authorizing the retention and employment of GCP as co-financial advisor to the Committee, effective as of August 23, 2024. *See* Docket No. 350.

7. On October 15, 2024, the Court entered the *Order Pursuant to 11 U.S.C. §§ 328(a) and 1103 Authorizing and Approving the Employment and Retention of Genesis Credit Partners LLC as Co-Financial Advisor to the Official Committee of Unsecured Creditors Effective as of August 23, 2024* authorizing the employment and retention of GCP as co-financial advisor to the Committee. *See* Docket No. 448.

C. The Interim Compensation Order

8. The Interim Compensation Order sets forth the procedures for interim compensation and reimbursement of expenses in these Chapter 11 Cases. Specifically, the Interim Compensation Order provides that each Retained Professional shall file a final fee application (the “Final Fee Application”) for the Final Period, for final approval and allowance of compensation and reimbursement of expenses sought by such Retained Professional in its Monthly and Interim Fee Applications. The Interim Compensation Order provides that Final Fee Applications shall be filed by any deadline established in a confirmed chapter 11 plan or an order of the Court.

D. The Plan and Confirmation Order

9. On December 18, 2024, the Court entered the *Findings of Fact, Conclusion of Law, and Order Approving the Disclosure Statement on a Final Basis and Confirming the*

Second Amended Joint Chapter 11 Plan of Liquidation for LL Flooring Holdings, Inc. and its Affiliated Debtors (the “Confirmation Order”) [Docket No. 701].

10. On December 20, 2024, the Debtors filed the *Notice of (I) Entry of Confirmation Order, (II) Occurrence of Effective Date, and (III) Related Bar Dates* [Docket No. 730] (the “Effective Date Notice”).

11. Pursuant to the Confirmation Order, and as set forth in the Effective Date Notice, each Retained Professional who holds or asserts a Professional Fee Claim is required to file with the Court, and serve on all parties required to receive notice, a Final Fee Application within forty-five days after the Effective Date (*i.e.* Monday, February 3, 2025), for final Allowance of compensation for services rendered and reimbursement of expenses incurred.

RELIEF REQUESTED

12. By this Application, and pursuant to the Interim Compensation Order, the Confirmation Order, and sections 330 and 331 of the Bankruptcy Code, GCP is seeking: (i) compensation in the amount of \$95,352.00, which is equal to eighty percent (80%) of the \$119,190.00 in fees for professional services rendered by GCP during the Monthly Period and (ii) compensation in the amount of \$1,313,120.00³ in fees for professional services rendered by GCP during the Final Period. This amount is derived solely from the applicable hourly billing rates of GCP personnel who rendered such services to the Committee. In addition, GCP is seeking reimbursement of expenses incurred during: (i) the Monthly Period in the amount of \$944.96⁴ and (ii) the Final Period in the amount of \$10,464.39⁵.

A. Compensation Requested

13. Attached hereto as **Exhibit A** is a detailed itemization, by project category, of all services performed by GCP with respect to the Chapter 11 Cases during the Monthly Period and Final Period. This detailed itemization complies with Local Rule 2016-2(d) in that each time entry contains a separate time allotment, a description of the type of activity and the subject matter of the activity, all time is billed in increments of one-tenth of an hour, time entries are presented chronologically in categories, and all meetings or hearings are individually identified. *See* DEL. BANKR. L.R. 2016-2(d).

14. The professionals who rendered services related to each category are identified in **Exhibit A**, along with the number of hours for each individual and the total compensation.

B. Expense Reimbursement

15. GCP incurred out-of-pocket expenses during: (i) the Monthly Period in the amount of \$944.96⁶ and (ii) the Final Period in the amount of \$10,464.39⁷. Attached hereto as **Exhibit B** is a description of the expenses actually incurred by GCP in the performance of services rendered as co-financial advisor to the Committee. The expenses are broken down into categories of charges, including, among other things, the following charges: airfare, data connectivity, information technology, lodging, meals, and transportation. *See* DEL. BANKR. L.R. 2016-2(e).

Summary of Services

16. During the Final Period, the Committee relied heavily on the experience and expertise of GCP in dealing with matters described in detail below. As a result, GCP's highly skilled restructuring and bankruptcy professionals devoted significant time and effort to perform properly and expeditiously the required professional services.

17. A summary of some of the more significant services rendered by GCP during the Final Period follows. This summary is divided according to the project categories used by GCP in its billing in these cases.

A. Business Analysis / Operations

Final Fees: \$427,525.00

Final Hours: 650.1

18. GCP professionals analyzed and assessed diligence materials provided by the Debtors; analyzed the Debtors liquidity and associated DIP forecast, analyzed the Debtors' financial performance during the case against their forecasts; benchmarked comparable companies, professional fees, real estate transactions, and debtor-in-possession economics; analyzed inventory levels and participated in discussions with the Debtors' financial advisor as it relates to the same topic; analyzed the four-wall profitability by store locations; monitored and analyzed the Debtors' going out of business sales; investigated the solvency of the Debtors at various points in time and analyzed certain corporate actions; analyzed the Debtors' borrowing base and related lender reporting; engaged with the Debtors' advisors regarding materials provided; analyzed the wind-down budget; engaged with Creditors regarding voluntary 503(B)(9) claim reductions; and analyzed certain employee retention payments.

B. Committee Activities

Final Fees: \$270,620.00

Final Hours: 398.0

19. GCP professionals prepared Committee update presentations and other materials including those related to case strategies, updates, and recoveries; participated in regularly scheduled meetings with the Committee and its professionals and the Debtors and their professionals; conferred with Committee counsel on numerous issues of interest; participated in discussions with 503(B)(9) creditors; and investigated issues of interest and created analyses as requested.

C. Sale Process

Final Fees: \$223,395.00

Final Hours: 319.4

20. GCP professionals researched and conducted outreach to potential investors; analyzed the retention of the Debtors' investment banker; analyzed the bidding procedures order and related sale process filings; participated in discussions with the Debtors and their investment bankers and other professionals; participated in discussions with the Committee and its professionals; analyzed various indications of interest; participated in negotiations with the buyer; benchmarked the value of certain bids; and analyzed the asset purchase agreement, funds flow, and other related closing documentation.

D. Claims Analysis and Objections

Final Fees: \$197,575.00

Final Hours: 273.4

21. During the Final Period, the Applicant's professionals analyzed lease rejection claims and related impacts to the claims pool; reviewed and analyzed proofs of claim to assess initial pool sizing estimates; participated in discussions with creditors regarding 503(B)(9) claim settlements and concessions; and worked to understand underlying assumptions with respect to estimated claims pool and other calculations.

REASONABLE AND NECESSARY SERVICES

22. The services for which GCP seeks compensation were, at the time rendered, necessary for, beneficial to and in the best interests of the Committee and the Debtors' estates. The services rendered were consistently performed in a timely manner commensurate with the complexity, importance and nature of the issues involved. In accordance with the factors enumerated in section 330 of the Bankruptcy Code, it is respectfully submitted that the amount requested by GCP is fair and reasonable given (a) the complexity of these Chapter 11 Cases, (b) the time expended, (c) the nature and extent of the services rendered, (d) the value of such services, and (e) the costs of comparable services other than in a case under this title.

CERTIFICATION OF COMPLIANCE AND WAIVER

23. The undersigned representative of GCP certifies that he has reviewed the requirements of Local Rule 2016-2, and that the Application substantially complies with that Local Rule. To the extent that the Application does not comply in all respects with the requirements of Local Rule 2016-2, GCP believes that such deviations are not material and respectfully requests that any such requirements be waived.

NOTICE

24. GCP will provide notice of this Application by electronic mail to: (i) the Debtors; (ii) counsel for the Debtors; (iii) the U.S. Trustee; and (iv) all parties in interest required to receive notice pursuant to Bankruptcy Rule 2002. In light of the nature of the relief requested, GCP submits that no other or further notice is required.

CONCLUSION

WHEREFORE, GCP respectfully requests the Court enter an order: (i) granting the Application and authorizing monthly allowance of compensation in the amount of \$95,352.00 (80% of \$119,190.00) for professional services rendered, and reimbursement of actual and

necessary costs in the amount of \$944.96⁸ incurred, during the Monthly Period; (ii) granting the Application and authorizing final allowance of compensation in the amount of \$1,313,120.00⁹ for professional services rendered, and reimbursement of actual and necessary costs in the amount of \$10,464.39¹⁰ incurred, during the Final Period; (iii) authorizing the payment of the amounts requested in the Application; and (iv) granting such other and further relief as the Court may deem just and proper.
