**Re: Reliant Life Shares, LLC  
DEADLINE TO FILE CLAIM: FEBRUARY 14, 2025**

Dear Creditor:

On October 7, 2024, Reliant Life Shares, LLC (“Reliant” or the “Debtor”) filed for bankruptcy under Chapter 11 of the United States Bankruptcy Code and is seeking to reorganize its debts.

You are receiving this Notice because you have been identified as someone who may have given money to Reliant or to someone acting on its behalf and have not been repaid in full or otherwise may be owed a debt from Reliant. This means you may have a CLAIM against Reliant.

In order to protect your rights and assert your Claim, you must either complete and file the enclosed Proof of Claim Form or submit it electronically at [www.cases.stretto.com/reliantlife](http://www.cases.stretto.com/reliantlife) **NO LATER THAN February 14, 2025. THIS IS THE PROOF OF CLAIM DEADLINE. If you have already filed a Proof of Claim, please do not file another one.**

A Proof of Claim is a formal document that tells the Court and the Debtor how much money you believe you are owed. The Proof of Claim Form contains instructions for how to complete it and the information that is required.

In order to participate in the bankruptcy case and potentially receive a distribution on account of your Claim, the completed Proof of Claim must be electronically filed at [www.cases.stretto.com/reliantlife/](http://www.cases.stretto.com/reliantlife/) OR mailed to the following address:

If the completed Proof of Claim is not received at the above address by **February 14, 2025**, you may not be eligible to receive any distribution from the bankruptcy case. You may also lose your ability to assert your Claim against Reliant and be **forever barred** from seeking repayment of any monies or debt that may be owed to you in connection with your Claim. After you complete the Proof of Claim, keep a copy for your records.

This letter is not intended nor should it be construed to offer legal advice and does not create an attorney-client relationship. Should you wish to consult legal counsel to assist with your Claim or the completion and/or filing of the Proof of Claim, you must retain an attorney to represent you.
