Weinick, Esq., in either case, so as to be received no later than the date to be set by the Court (the “**Response Deadline**”) which date will be posted on the Receivership website (<https://www.legendreceivership.com/>) and mailed and/or e-mailed to all investors and claimants to the extent their addresses are known to the Receivership. The Receiver will consolidate and file any non-party opposition or other responses as a single docket entry no later than three (3) business days following the Response Deadline. The Receiver’s reply papers, if any, will be filed by the date to be set by the Court.

PLEASE TAKE FURTHER NOTICE that, in the absence of any timely filed or served written opposition, the Court, without further hearing or notice, may enter the proposed Order Granting the Receiver’s Motion to Establish Procedures for Resolution of Interests and Claims and Setting Bar Dates for Claims submitted herewith.
