NOTICE OF RECEIVER’S CLAIMS ANALYSIS REPORT

<p>PLEASE CAREFULLY READ THE ENTIRETY OF RECEIVER’S CLAIMS ANALYSIS REPORT, INCLUDING THE ATTACHMENTS, AS YOUR RIGHTS MAY BE AFFECTED.</p>

Pursuant to order dated July 7, 2023 [Dkt. 56], the Court appointed Melanie L. Cyganowski as Receiver (in such capacity, the “Receiver”) of the Receivership Entities.¹ On May 28, 2025, the Receiver filed her “Motion for Entry of an Order Establishing Procedures for Resolution of Claims and Interests and Setting Bar Dates for Claims” [Dkt. 174], which the Court granted by order dated June 26, 2025 [Dkt. 190], thereby establishing procedures for the resolution of Interests and Claims (the “Procedures”) [Dkt. 168].

In accordance with the Procedures, the Receiver has prepared a Claims Analysis Report setting forth the Receiver’s determination regarding Proofs of Claim (as that term is defined in the Procedures) that were submitted to the Receiver. The Claims Analysis Report² is comprised of the schedules (the “Schedules”) annexed to this Notice. The Schedules do not necessarily provide the full basis for the Receiver’s determination of any Claim, and the Receiver reserves all rights to provide further, different and additional bases for her determinations.

The Schedules categorize the Claims and Interests into groups that are deemed to share common characteristics, as follows:

1. **Schedule A: Claims Filed by Investors.** These are Proofs of Claim filed by Investors on account of Interests.
2. **Schedule B: Other Claims.** These are Proofs of Claim filed by persons, other than Investors, against Legend.

² Except as otherwise defined in this Notice or the Schedules, all capitalized terms shall have the meanings ascribed to them in the Receiver’s Plan of Distribution [Dkt. 180-1] that was approved by Court order dated August 29, 2025 [Dkt. 210].

Please read all of the Schedules in their entirety. If a Claimant filed multiple Proofs of Claim, the Receiver may have categorized each of the Claims in different Schedules. Schedule A lists each Investor by Investor Number. Schedule B lists each Claimant alphabetically.

The Procedures set forth how Claimants can object to the Receiver's determination of their Claim(s) as set forth in the Schedules. The Procedures can be obtained free of charge on the Receiver's website: <https://cases.stretto.com/legendreceivership/>.

In accordance with the Procedures, an objection to the Receiver's determination of a Claim must be (i) be in writing, (ii) state with particularity the basis and nature of the objection (as to which the Receiver reserves all rights) and (iii) be electronically mailed to the Receiver's counsel at LegendReceiver@Otterbourg.com **so as to be actually received not later than 45 days after the date of this Notice.** Objections should not be filed with the Court.

The Receiver's determination of a Claim or Interest shall be final and binding for all purposes, including with respect to the Plan, unless the Claimant timely and properly submits an objection or takes other action as set forth in the Procedures.

Please note that nothing in this Notice or the Schedules is intended to or shall be deemed to (i) affect, modify or limit any Court Order or any provision of the Procedures or the Plan, which shall be enforceable according to their terms, or (ii) state or guarantee any distribution on account of any Claim or Interest.
