**NOTICE OF HEARING TO CONSIDER APPROVAL OF
DISCLOSURE STATEMENT FOR DEBTORS' JOINT CHAPTER 11 PLAN**

TO ALL PARTIES IN INTEREST:

PLEASE TAKE NOTICE on October 27, 2025, Broadway Realty I Co., LLC and its debtor affiliates (collectively, the “**Debtors**”), as debtors and debtors in possession in the above-captioned chapter 11 cases (the “**Chapter 11 Cases**”), filed the disclosure statement [ECF No. 671] (together with all exhibits and schedules thereto and as may be amended, modified, or supplemented, the “**Proposed Disclosure Statement**”) for the Debtors’ *Joint Chapter 11 Plan* [ECF No. 670] (together with all exhibits and schedules thereto and as may be amended, modified, or supplemented, the “**Plan**”). The Debtors have filed a motion (the “**Disclosure Statement Motion**”) [ECF No. 672] seeking entry of an order (the “**Disclosure Statement Order**”): (i) approving the Disclosure Statement as containing “adequate information” pursuant to section 1125 of title 11 of the United States Code (the “**Bankruptcy Code**”); (ii) establishing the Voting Deadline and other deadlines with respect to confirmation of the Plan; (iii) approving procedures for soliciting, submitting, tabulating votes on, and filing objections to, the Plan; and (iv) approving the forms and manner of certain notices in connection with confirmation of the Plan.²

PLEASE TAKE FURTHER NOTICE THAT:

1. A hearing (the “**Hearing**”) will be held before the Honorable David S. Jones, United States Bankruptcy Judge, in the Bankruptcy Court, One Bowling Green, Courtroom 701, New York, New York 10004, on **December 4, 2025 at 10:00 a.m. (prevailing Eastern Time)**, to consider entry of an order approving the adequacy of the information in the Proposed Disclosure Statement and other relief requested in the Disclosure Statement Motion.

2. Objections, if any, to approval of the Proposed Disclosure Statement or any of the relief requested in the Disclosure Statement Motion must: (i) be in writing; (ii) conform to the Bankruptcy Rules and the Local Bankruptcy Rules; (iii) set forth the name of the objecting party and the nature and amount of Claims or Interests held or asserted by such party against the Debtors’ estates or property; (iv) provide the basis for objection and specific grounds therefor, and provide proposed language that, if accepted and incorporated by the Debtors, would obviate such objection; and (v) be filed, together with proof of service, with the Bankruptcy Court no later than **November 25, 2025 at 4:00 p.m. (prevailing Eastern Time)** (the “**Disclosure Statement Objection Deadline**”), and be served upon the following parties so as to be actually received no later than the Disclosure Statement Objection Deadline:

- iv. counsel to Flagstar Bank, N.A., Paul Hastings LLP, MetLife Building, 200 Park Avenue, New York, NY 10166 (Attn: Brett Lawrence, Esq., Nicholas Bassett, Esq., Justin Rawlins, Esq., and Harvey A. Strickon, Esq.).

4. IF AN OBJECTION TO THE PROPOSED DISCLOSURE STATEMENT OR THE DISCLOSURE STATEMENT MOTION IS NOT FILED STRICTLY AS PRESCRIBED HEREIN, THE OBJECTING PARTY MAY BE BARRED FROM OBJECTING TO THE PROPOSED DISCLOSURE STATEMENT OR THE DISCLOSURE STATEMENT MOTION AND MAY NOT BE HEARD AT THE HEARING. IF NO OBJECTIONS TO THE PROPOSED DISCLOSURE STATEMENT OR DISCLOSURE STATEMENT MOTION ARE TIMELY FILED IN ACCORDANCE WITH THE PROCEDURES SET FORTH HEREIN, THE BANKRUPTCY COURT MAY ENTER AN ORDER APPROVING THE DISCLOSURE STATEMENT MOTION WITHOUT FURTHER NOTICE OR HEARING. THIS NOTICE IS NOT A SOLICITATION OF VOTES TO ACCEPT OR REJECT THE PLAN. VOTES ON THE PLAN MAY NOT BE SOLICITED UNLESS AND UNTIL THE BANKRUPTCY COURT ENTERS THE DISCLOSURE STATEMENT ORDER.
