The undersigned, being the sole member (the “Member”) of Purple Shark, LLC (the “Company”), a California Limited Liability Company, in accordance with the authority contained in the California Revised Uniform Liability Company Act and the limited liability company agreement of the Company, hereby takes the following actions, adopts the following resolutions and transacts the following business at a meeting of the Member held on September 28, 2025:

**WHEREAS**, the Special Committee of Thrill Holdings LLC (“Holdings”), the managing member of the Member, has recommended to Holdings and the Member that it is desirable and in the best interests of Holdings and the Company, and each of their creditors, members and other stakeholders, that a voluntary petition be filed by the Company, seeking relief under the provisions of Chapter 11 of Title 11 of the United States Code (the “Bankruptcy Code”), in the United States Bankruptcy Court for the District of Nevada (the “Bankruptcy Court”); and

**WHEREAS**, the undersigned Member, in consultation with the Member’s advisors including the recommendation of the Special Committee, have determined that it is desirable and in the best interests of the Company, and its creditors, members and other stakeholders, that a voluntary petition be filed by the Company, seeking relief under the provisions of Chapter 11 of the Bankruptcy Code in the Bankruptcy Court; and

**NOW, THEREFORE, BE IT RESOLVED:** the Company is hereby authorized to file for relief under the Bankruptcy Code, at such time as the Authorized Representative (appointed hereinbelow) determines such filing is required to protect the assets and operations of the Company;

**RESOLVED FURTHER:** that Jeremy Rosenthal, the Chief Restructuring Officer of Holdings is appointed as the authorized representative (the “Authorized Representative”) of the Company, in the Company’s Chapter 11 bankruptcy case to be commenced in the Bankruptcy Court (collectively, the “Chapter 11 Case”), and in such capacity, acting alone, with power of delegation, be, and hereby is, authorized and empowered to execute and file on behalf of the Company, all petitions, schedules, lists, applications, pleadings and other motions, applications, papers, agreements, consents or documents, and to take any and all action that the Authorized Representative deems necessary or proper to conduct the affairs of the Company in the Chapter 11 Case, including, without limitation, to negotiate, file and confirm a plan of reorganization for the Company;

**RESOLVED FURTHER:** without limiting the foregoing, the Authorized Representative shall be designated as the responsible person in the Chapter 11 Case pursuant to

Fed. R. Bankr. P. 9001(5), and is authorized and directed to appear in all bankruptcy proceedings on behalf of the Company, and to otherwise do and perform all acts and deeds and to execute and deliver all necessary documents on behalf of the Company in connection with the Chapter 11 Case;

**RESOLVED FURTHER:** the Member authorizes, direct, and ratify the retention of the law firm of Garman Turner Gordon LLP to represent the Company in such Chapter 11 Case as general bankruptcy counsel as provided for in its engagement agreement and as subject to any requisite Bankruptcy Court approval;

**RESOLVED FURTHER:** the Member authorizes, directs, and ratifies the retention of Force Ten Partners LLC to assist the Company in such Chapter 11 Case as financial advisors as provided for in its amended engagement agreement and as subject to any requisite Bankruptcy Court approval;

**RESOLVED FURTHER:** without limiting the foregoing, that the Authorized Representative, and such other persons as the Authorized Representative shall from time to time designate, and any employees or agents (including counsel) designated by or directed by any such person, be and each hereby is, authorized, empowered and directed, in the name and on behalf of the Company, to execute and file all motions, applications, pleadings and other papers, and to take and perform any and all further acts and deeds which he or she deems necessary, proper or desirable in connection with the Chapter 11 Case;

**RESOLVED FURTHER:** without limiting the foregoing, that the Authorized Representative, and such other persons as the Authorized Representative shall from time to time designate, and any employees or agents (including counsel) designated or directed by any such person, be and each hereby is, authorized, empowered and directed, in the name and on behalf of the Company, to cause the Company to enter into, execute, deliver, certify, file and/or record, and perform such agreements, instruments, motions, affidavits, declarations, applications, certificates or other documents, and to take such other action as in the judgment of such person shall be or become necessary, proper and desirable to effectuate a successful Chapter 11 bankruptcy case with respect to the Company;

**RESOLVED FURTHER:** all acts lawfully done or actions lawfully taken by the Authorized Representative of the Company in the name and on behalf of each of the Company to file the petition or in any other connection with the Chapter 11 Case, or any manner related thereto, or in furtherance of these resolutions be, and hereby are, in all respects ratified, confirmed and approved.

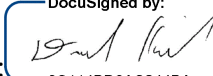

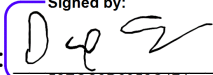

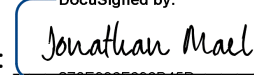
